Anand, Amul, Anand and ISRO, Ahmedabad together took a forward step for the benefit of dairy farmers by signing a Memorandum of Understanding for "Fodder acreage assessment using satellite observation and space technology". The main objective of this MOU is identification/discrimination between food crops & fodder crops at village level and identifying suitable areas of current fallows & cultivable wastelands at village level for green fodder cultivation. This is for first time in the India and probably in the world where Space research Organization and dairy cooperatives are together using satellite technology for fodder acreage estimation. Amul is procur-

by using this technology. AMUL believes that the development and growth of dairy animals are highly associated with the scope of availability of fodder from cultivable land, forest, pastures and grazing lands which are crucial input for enhancing milk production and also for survival of the bovine population. Amul has distinguished the importance of the fodder crop estimation and Space Application centre (SAC, ISRO), Ahmedabad has developed space based remote sensing for fodder crop assessment using satellite observation and space technology.
